

It is most respectfully submitted that I have been transferred from Gorakhpur to Banda in the Annual transfer of 2021 by the Hon'ble High Court.

My wife Smt. Priyanka Kanodia is a U.P. Government employee and was working as Area Rationing Officer at District Supply Office Gorakhpur. Her transfer was also due in the year 2021 and she was transferred from Gorakhpur to Lucknow by the U.P. Government in July, 2021. My wife Priyanka Kanodia joined as Area Rationing Officer at District Supply Office on 13 July , 2021. Which has forced both of us to live at different stations.

It is humbly submitted that I have moved a Representation to the Hon'ble High Court to get me transfer from Banda to Lucknow. It is also pertinent to mention here that I have applied for the deputation post of Judicial Member Commercial Tax Tribunal Aligarh in October 2020. While my representation was still under consideration, the Hon'ble Court was pleased to approve my application for the post of Judicial Member Commercial Tax Tribunal Aligarh and I was posted at Aligarh while my family is residing at Lucknow.

It is further most respectfully submitted that I have two tender aged daughters Parnavi Agrawal aged about 13 years and Prashasti Agrawal aged about 11 years studying in Class 8 and 6 respectively at City Montessori School Gomti Nagar Extention Lucknow. My mother Smt. Sharda Devi aged about 68 years is living with me after sad demise of my father due to her old age she is suffering from various ailments like High Blood Pressure and stiff Knee Joints. My mother needs to be looked after and requires extra care. It is most humbly submitted that my entire family is living at

Lucknow and due to the nature of my wife's job she has to go in fields and therefore seldom come home in time which renders her unable to take proper care of our daughters and my mother alone. It is also not possible for me to come Lucknow even in weekends as Aligarh is almost 450 km. away from Lucknow and there are only few trains after office hours which reaches Lucknow on odd time. Few transportation along with COVID 19 conditions makes it more tough for me to go Lucknow and it is also not safe for me and my family to frequent travel in public transport. Even my wife Priyanka Kanodia can not be transferred to Aligarh because Incharge District Supply Officer posted at Aligarh is junior in rank to my wife.

I am therefore compelled by the above circumstances to most humbly pray to the Hon'ble Court to transfer me from Aligarh to;

\* Lucknow or Barabanki or;

\* Any deputation post at Lucknow or;

\* Additional Principal Judge Family Court Lucknow,

so that I can fulfil my obligation towards my family and can discharge my official duties sincerely.

It is most humbly requested to place my representation before the Hon'ble Court for sympatatic and kind consideration. I shall always remain highly obliged.
