Gastric mucosa with underlying tumor in glandular and nesting pattern comprising of cells having vesicular to hyperchromatic nuclei and abundant vacuolated cytoplasm. Mitosis is brisk.

Comment: <5% of gastric adenocarcinomas are positive for SATB2, therefore, in view of positivity for SATB2 and CK-7 together with CDX-2, a small intestine primary needs to be ruled out. Clinicoradiological and colonoscopic correlation is strongly recommended.

- Tests performed using Polymer detection system.
