Subject: Mercy Petition for transfer from Maharajganj District on the
ground of own health related condition and education of
children.

Respected Sir,

The applicant most humbly begs to submit that:-

(1) The applicant was transferred to District Maharajganj from Kanpur Nagar in annual chain of Transfer Year 2022 vide notification No. 560 /Admin. (Services)/2022. The applicant has taken charge.

(2) Sir, my present place of posting- District Maharajganj is one of the very remote and rural districts in state where nominal medical and educational facility exists. In case of any emergency one has to rush to Lucknow or other district. I am suffering from post COVID-19 complications, including increased blood glucose level, breathlessness and heart related problems. I was undergoing medical treatment for these ailments at my previous place of posting viz Kanpur Nagar. Now I have to take long leaves to travel to Varanasi or any other city for taking treatment. This hampers my work and also increases my financial & physical burden. I have attached medical papers regarding these ailments.

(3) My daughter Km. Priyanshi aged 13 years is studying in Class IXth and in next year she has to be enrolled in Class Xth. Apart from her, I have twins- a son and daughter, aged eight years, who are also studying. Since all of my children are in tender ages, I have to keep them with me at the place of my posting. They reside with me and get education at the place of my posting. My current place of posting- District Maharajganj, is a very remote place at Nepal border and the district is lacking of proper educational facilities. There are no good schools and absolutely no Centre for preparation of medical/engineering admission test. This is causing great loss to my children.

(4) In above facts and circumstances, it is most humbly requested that the Hon'ble High Court may be pleased to transfer me in the anyone places mentioned in my choice for annual posing earlier viz district- Lucknow, Agra, Ghaziabad, Bareilly, Meerut or Aligarh as these places have good educational and medical facilities. Since I am ready to

forego composite grant and travel expenses in case my application is granted, hence this transfer does not fall in the category of financial burden on state exchequer under rule 42 of Chapter-IV of F.H.B. Volume-III.

Respected Sir, it is therefore, my most humble prayer to your good offices that my this representation may kindly be placed before the Hon'ble Court for kind and sympathetic consideration for which I along with my family shall remain highly obliged to Hon'ble Court for the rest of my life.
