DISCHARGE SUMMARY

Treatment given during hospitalization:

Patient was admitted under supervision of Neuro surgeon with complaints of sudden clumpiness noted in right hand at 08:00pm on 20/11/2021 and found to have high BP ~ 240mmHg systolic then developed right hemiparesis with facial palsy and slurring of speech, deviation of mouth. After initial treatment patient was shifted to HDU for further management. Required investigations were done during hospitalization detailed reports attached. Cardiologist opinion was taken for CAD and advice followed. Physiotherapy was done. Prognosis explained to attendants. Physician opinion was taken for DM and HTN. Neuro physician opinion was taken for dull and drowsiness. Carotid doppler showed eccentric plaque extending into left ICA causing 30-50% narrowing hence CTVS opinion was taken. Psychiatric opinion was taken. Holter monitoring was done. CT Angiography Neck was done. MRI Brain was done. CT Angiography was done which was normal. Patient was treated and managed conservatively. When patient was symptomatically better he was shifted to ward. During hospitalization patient was put on IV Fluid, Inj Kephazone S forte, Inj Pantocid, Inj Emset, Inj Cerebrolysin, Inj Aravon, Tab Ecosprin, Tab Deplatt and other supportive treatment. Today patient is being discharged in stable condition.

Patient's Condition at the Time of Discharge:

Vitals Stable, Conscious, Oriented, Afebrile.


