**Re: Representation Prayer for Stay for the year 2023-2024**

Respected Sir,

It is humbly submitted that I am posted as Additional Civil Judge (J.D.) Ghaziabad by Hon'ble Court Notification. Thereafter, the Hon'ble Court had been pleased to post me as Officer on special Duty at National Legal Service Authority, New Delhi in diverted Capacity vide notification No. 44/Admin.(Services)/2022 and I had been posted there till 15-09-2022 & thereafter, I joined at my original place of posting at Ghaziabad. Now my annual transfer is due in normal course.

It is humbly submitted that my father-in-law Shri. Jaibir had brain stroke on 20.11.2021 and in the said emergency & critical medical condition, he was admitted and treated at Yashoda Hospital, Ghaziabad and discharged on 30.11.2021 after long hospitalization. However, he continues to be paralysed and bedridden. He requires regular consultations, treatment and physiotherapy from the treating doctors & experts from my official residence. Medical certificate / Prescription is annexed herewith for ready reference of your honour. My official residence is nearby Yashoda Hospital & therefore, my posting at Ghaziabad makes it economically and otherwise feasible & convenient for me to continue the treatment of my ailing father-in-law. The said treatment will not be possible due to financial implications of residence and lack of close supervision and availability of immediate medical facilities had I not happen to be posted at Ghaziabad. It is further humbly submitted that this is my first posting of the my Judicial Service and I also underwent initial training while being posted at Ghaziabad. Thereafter, I had to avail maternity leave due to birth of my daughter from 9.9.2020 to 7.3.2021. However, thereafter I was posted in diverted capacity at National legal Service Authority at New Delhi. In the aforesaid situation, I could not get exposure to core Judicial work at Ghaziabad. I have now acclimatized in the Judicial environment at Ghaziabad and it is hence humbly prayed that I may kindly be granted one year stay so that I may learn Judicial Work speedily in continuity besides looking after the medical needs of my father-in-law which is likely to be severely hampered due to lack of accommodation for paralysed patient.

In the aforesaid exigencies, it is humbly prayed that I may kindly be granted for one year stay at Ghaziabad.

It is further humbly prayed that my representation / prayer for stay for one year at present place of posting at Ghaziabad may kindly be placed before the Hon'ble Court for kind consideration.
