Subject: Application for Premature transfer from Jaunpur Judgeship.

Respected Sir,

Jaunpur.

The applicant Dinesh Kumar Diwakar Nyayadhikari, Gram Nyayalaya, Sahaganj, Jaunpur was transferred to Jaunpur vide Notification No. 1060/Admin. (Services)/2022 Dated 03.07.2022 of the Hon'ble High Court and pursuance whereof the applicant took over at Gram Nyayalaya, Sahaganj, Jaunpur on dated 05.07.2022.

The applicant want to crave the permission to request your good self for his transfer from his present place of posting to some other place near Lucknow or Delhi and also want to attract the kind attention of your good self towards the problems and the hardships which the applicant is facing as the same will definitely be aggravated due to the above described transfer as the same would result into the bitter state of affairs which the applicant is facing are described as below-

(A) That, the mother of the applicant is an old lady aged about 69 years. She is taking treatment for Ortho-arthritis problems at Lucknow. But the last 6 months her movement has become quite restricted due to her illness and she is confined to bed at home. Doctor of KGMU told that the problem of Ortho-arthritis is in advance stage in this month. Doctor has also advised that medicines will help only up to an extent and

knee transplant is the only alternate. It has been advised for knee transplant as soon as possible. The expenses and the liabilities regarding her treatment are being borne by the applicant. The applicant has to solely manage the arrangement regarding her treatment. Applicant wants to get her treated either in Lucknow or in Delhi where medical facilities are up to the mark but the same is not possible while his posting at Sahaganj, Jaunpur.

(B) That the applicant has two babies, first is aged about Five years and another one Year six months old who require personal attention of the applicant. but the applicant has to leave his wife time to time with his ailing mother as she is the only person available to care of her in absence of applicant.

That, the applicant is solely responsible of taking care and well being of his family. Due to applicant being posted at Sahagang, Jaunpur, it is not possible for him to devote enough time to his wife and other family members who are in need of his continuous care and attention. As a result of the above mentioned hardships, the applicant remains in continuous mental stress due to these cause of concerns for him.

Applicant being a devoted judicial officer who performs his duty up to his abilities with full sincerity, devotion, honesty and integrity as required by this esteemed service. In view of the above mentioned personal problems and hardship as described above, the applicant most respectfully requests that his case for premature transfer may be considered sympathetically to any place nearer to Lucknow or Delhi wherever your good self deem fit and proper.

The applicant shall ever remain grateful to Hon'ble Court for this act of kindness.
