Greeting for the day.

I wish to submit on the above subject that I have been asked to intimate on certain points. Sir, broadly there are three queries and I would like to answer them in the following words-

- i. I have not yet submitted my Ph.D. thesis as I have been waiting for the Hon'ble Court's permission;
- ii. I have not completed my Ph.D. prior to joining this service;
- iii. I apologize for the delay in asking for the permission to submit my Ph.D. thesis. Sir, when I joined this service on 15th November 2019, I was not certain whether I'll be able to complete my Ph.D. along with my job as a judicial officer. After joining the service, I have been sincerely focusing on my training (institutional as well as field). However, I have been working on my Ph.D. on weekends or as and when I got spare time (which has not in any way affected my judicial work). It is only when I became certain as to the fact that I am almost done with my thesis, I applied before the Hon'ble Court for permission to submit my Ph.D. thesis.

It is to bring into your kind notice that I joined the Ph.D. program in Nov 2016 and before my joining of service in 2019 I completed my two years residency on Nov. 2018 as per the UGC norms. During the said 2 year residency period I completed my course work of which I have attached a copy of result/marksheet.
