Subject: **Regarding premature transfer on the ground of critical illness
and Cancer treatment of Mother-in-law at AIIMS Delhi.**

Respected Sir,

It is to be submitted humbly that I have been recently transferred to Ramabai Nagar in previous general transfers. I had previously applied for over stay at Bulandshahr on the ground of Cancer treatment of my mother-in-law at AIIMS Delhi, Hon'ble Court has been pleased to transfer me and my husband Mr. Amarjeet Addl. District and Sessions Judge, to Ramabai Nagar.

On the basis of early diagnose District Hospital Bulandshahr referred her for treatment at a higher center. Doctors at All India Institute of Medical Sciences (AIIMS), Delhi have confirmed that she was suffering from Cervix Cancer of Stage II B.

The course of treatment for the Cancer being given by the Doctor at AIIMS is "Definitive Chemo Radiation along with weekly Cisplatin" followed by "Intracavitary Radiotherapy (ICRT) sessions" and follow-up. For this treatment my mother-in-law has been admitted in All India Institute of Medical Sciences (AIIMS), Delhi first time on 15.02.22 and further many times. Till now she had more than 42 visits to AIIMS Delhi for radiation and chemotherapy, and latest on 21.11.22

Ramabai Nagar is not only 450 km away from Delhi but even basic medical facilities are not available here in case of any emergency. My mother-in-law Veermati Devi w/o Late Shri Tejpal Singh, a senior citizen, is solely dependent on us for her care, attention, medical needs and support. She is permanently residing with us. She is getting regular treatment of Cancer through Chemotherapy and radiation from AIIMS, Delhi. She has to undergo frequent admission for Chemotherapy at the AIIMS Delhi and frequent visit for radiation is essential part of her treatment. She needs constant medical, emotional care and attention due to the side effects of



Chemotherapy. Hence in the said scenario it is not possible to continue without putting her well-being and life at risk.

In this life saving struggle, our transfer to Ramabai Nagar has caused immense hardship and difficulty to her to undertake such long journey and continue her treatment resulting in huge interruption of treatment from AIIMS, Delhi. Disturbance in treatment is adversely affecting her medical condition and fight against Cancer. It is extremely urgent and necessary for us to continue her regular treatment, checkup, care and recovery of my mother-in-law. It is also humbly mentioned that it is not possible for me also to reside elsewhere with her for this obligation. My husband Mr. Amarjeet, Addl. District and Sessions Judge Ramabai Nagar has also moved his representation.


