Respected Sir,

Most respectfully, I am submitting before the Honourable High Court at Allahabad that I am applying for Stay of Transfer on present place of my posting outline Khurja, Bulandshahr on the following grounds:-

- 1. I have joined U.P. Judicial Services vide Hon'ble Court Notification No. 1807/Admin (Services) 2018 dated 13th June, 2018 at District Etah on 14th June, 2018. I got transferred to Khuria (outline of Bulandshahr) on 14th April, 2021.
- 2. It is pertinent to mention here that from July 2020 every month I had severe pain in my abdomen and it lasted for weeks. I went for a check up at my hometown where Doctor directly recommended me to go to Delhi or Chandigarh seeing the situation at this age. I consulted Retired AIIMS Director and gyne-iap surgeon at Paras Hospital, Gurgaon where she diagnosed me with Deep Endometriosis of stage 4 with severe adenomyosis for which I was asked to go for surgery of lower abdomen and required to be on medicine and regular strict follow up by having MRI and USGs done by only expert specialist as it is chronic disease has to be monitored properly and 90% chance of recurrence even after surgery. It said it affects other body parts and mainly affects female parts in worse condition. The only option is to remove that



body part completely. I even took an opinion from a senior gynecologist surgeon in PGI

Chandigarh. She said the same thing as it is already widespread in my lower abdomen and

affected a large area so risk won't be taken further. In order to prevent any more damage I have

been advised to be on regular check ups and proper treatment.

1 got married in July,2021 and my husband is posted in Gujarat as a Government

Officer. Due to proper medical treatment, I got pregnant and my expected date of delivery is in

April,2022. As my husband is posted in a different State, I have to travel most of the time alone

for medical check up and follow ups. So at that moment when I need proper medical supervision

and care, it will be very difficult for me to commute to another district.

4. It is important to note here that as I am in utmost need of extensive care and proper

treatment at this very point of my age. I was posted at Khurja in April,2021 and will be

completing two years in April,2023. So applying for stay of transfer for one year at headquarter

Bulandshahr or at outline Khurja. While considering all the aforesaid reasons, it is my humble

submission to the Hon'ble Court to kindly consider my application and be pleased to stay my

transfer at Khurja or at headquarter Bulandshahr for one year. So that, I may be able to take

proper treatment and discharge my official duties effectively and efficiently.

You are, therefore, most respectfully requested to kindly place my representation

before Hon'ble Court for its kind consideration. I shall be highly obliged and ever be grateful.
