Subject: Representation for transfer

Sir,

With humble submission the undersigned is taking the opportunity to bring it to your benign notice that I joined as Additional Civil Judge(Junior Division) in District Judgeship Pratapgarh on 1st May, 2023.

With reference to above subject matter, I humbly submits as unde :-

- 1. Before joining in district Pratapgarh, I was posted as Nyayadhikari, Gram Nyayalaya, Baghpat and after completing the term of three years at that station I was transferred to Pratapgarh in the Annual Transfer after which I have taken over the charge as Additional Civil Judge on 1.5.2023
- 2. It is relevant to mention that my wife is working as a visiting faculty in Campus Law Centre, University of Delhi and she is also pursuing her Ph.D in law from Faculty of Law, University of Delhi. In this background, her Ph.D thesis is due for submission after December'2023. My wife was residing with me when I was posted at Baghpat. After my annual transfer she is staying in hostel and traveling weekly to Pratapgarh. In this regard it's crucial that to complete her Ph.D in time along with her job we stay in and around Delhi. The letter from her college is annexed herewith.

- 3. Sir, it is further relevant to mention that my Father-in-Law was diagnosed with Urinary Bladder Cancer in the month of July'2022. It had relapsed because he underwent surgery for it in the year 2019 also. He has undergone a surgery for the same in the month of August'2022. The biopsy report stated that it's high grade papillary urothelial carcinoma. At present he is undergoing treatment for the same from Fortis Escorts, Okhla, Delhi. As he is permanent resident of Patna, Bihar and there is no one other than me in NCR to look after him. He is currently staying with us for his chemo treatment which will go on till 29th December'2023. The treatment comprises of weekly, monthly and quarterly doses of chemo. The medical records of the treatment are annexed herewith.
- 4. There is none in the family of my father to care of him. I oftenly used to take him to New Delhi for his check up for which I used to take leave. While posted in Baghpat it was possible for me to take only one Casual Leave for taking him to the Hospital as distance between Baghpat and New Delhi was only 50 Kilometres. After being transferred to Pratapgarh this distance has increased to 800 Kilometres wherefore now I am required to take minimum three days leave for taking him to Hospital and to be back home for one visit as distance between Pratapgarh and New Delhi is around 800 kilometres
- 5. My Father Ashok Kumar Sharma aged 73 years and my mother Manju Sharma aged 65 years reside in Rohtak, Haryana. While being in Baghpat I was able to attend to their medical needs by visiting them once in a week. However, after joining in Pratapgarh I've not been able to visit them once.
- 6. In the abovementioned circumstances it is necessary that I stay in NCR region.

It is in the above background that your good self is beseechingly is desirable to get me transferred to any station near New Delhi so that while discharging my duties as judicial officer my wife can continue with her Ph.D and job. I may be able to take care of my ailing father-in-law and my ageing parents without any difficulty.

I, therefore, request you to kindly place my representation before the Hon'ble Court for favourable order for which I shall remain highly obliged.
