

Subject:- Representation for Premature Transfer on Medical Ground.

Hon'ble Lordship,

With due to regards, My humble prayers are as follows:-

- 1- I have been suffering from Cervical Spine-cum-neckpain with reghand pain since last year. Due to some problem of Cervical Spine, my right-hand palm is shrinking, which is my forehead, and a continuous pain is present in my neck with right hand. Initially I showed myself in Department of J.N. Medical College and Hospital, AMU, Aligarh. (The copy of the **Treatment Card** is attached & marked as **Annexure No. 01** for the kind perusal of Hon'ble Court.)
- 2- The doctor of J.N. Medical College and Hospital, AMU, Aligarh advised me to get MRI Test of Cervical Spine. Then I got MRI done. The report of MRI showed that, "**MRI morphology is suggestive of Disc-dessication with mild diffuse and left paracentral disc bulge at C5-C6 causing mild thecal indentation with mild narrowing of spinal canal diameter & disc dessication at C3-C4 & C4-C5 level.**" (The copy of the **MRI Report** is attached & marked as **Annexure No. 02** for the kind perusal of Hon'ble Court.)
- 3- After seen MRI Cervical Spine, The doctors of J.N. Medical College and Hospital, AMU, Aligarh told me that this is a case related to Neurophysician having super-speciality like D.M. in Neurology & there is Department of Neurology in **AIIMS, New Delhi / G.B. Pant Hospital, New Delhi**. Then they referred me to the Department of Neurology in **AIIMS, New Delhi / G.B. Pant Hospital, New Delhi**. (The copy of the **Referral Report** is attached & marked as **Annexure No. 03** for the kind perusal of Hon'ble Court.)
- 4- Thereafter, I showed myself in the Department of Neurology , **AIIMS, New Delhi** where the Neurophysician / Professor told me that treatment will take a long time & after each one month, you will have to come. He advise me to get NCV/NCS test after each 20 days. (The copy of the **Treatment Card of AIIMS, New Delhi** is attached & marked as **Annexure No. 04** for the kind perusal of Hon'ble Court.)
- 5- At Present, I am posted as Addl. Civil Judge (Senior Division), **Maharajganj**. No such facility of treatment is available in District Maharajganj or nearby.

6- If I am transferred to any of the district nearby New Delhi, it will be easy for me **to take proper treatment from AIIMS, New Delhi.**

7- It is submitted that I have not presented any representation earlier on the similar ground as mentioned in current application.


