Subject: Representation for pre-mature transfer due to own medical  
condition and education of children.

Respected Sir,

The applicant most humbly begs to submit that:-

(1) The applicant was transferred to District Maharajganj from Kanpur Nagar in annual chain of Transfer Year 2022 vide notification No. 560 /Admin. (Services)/2022. The applicant will be completing two years of posting in current annual chain- 2024.

(2) I most humbly submit that I have undergone two major surgeries for Cholelithiasis with Cholecystitis and Umbilical Hernia at Dr Nawal Kishore Hospital at Agra under supervision of Dr Gyanprakash on 16.08.2023. The Doctor has certified that due to medical co-morbidity, I require follow up in higher center. The medical certificate and discharge summary is being submitted with this application. Further, due to my earlier health condition resulting from post COVID-19 complications, viz increased blood glucose level, COPD and heart related problems, he had advised routine follow up in higher center. I was undergoing medical treatment for these ailments at my previous place of posting viz Kanpur Nagar. Now I have to take long leaves to travel to higher center in any other city for taking treatment.

(3) My daughter Km. Priyanshi aged 15 years is studying in Class Xth and in next year she has to be enrolled in Class XIth. Apart from her, I have twins- a son and daughter, aged seven years, who are also studying. Since all of my children are in tender ages, I have to keep them with me at the place of my posting. They reside with me and get education at the place of my posting. My current place of posting- District Maharajganj, is a very remote place at Nepal border and the district is lacking of proper educational facilities. There are no good schools and absolutely no Centre for preparation of medical/engineering admission test. Hence I have to temporarily shift my elder daughter to Varanasi. This is causing great loss to my children.

(4) My present place of posting- District Maharajganj is one of the very remote and rural districts in state where nominal medical facility

exists. It is not possible to travel frequently to higher centre for treatment. If I have to apply for leave, then judicial work suffers and it also increases my financial & physical burden. I am attaching medical papers regarding above mentioned facts.

(5) In above facts and circumstances, it is most humbly requested that the Hon'ble High Court may be pleased to transfer me in any place mentioned in my choice of posting so that I can get medical help for my emergent medical need. Since I am ready to forego composite grant and travel expenses in case my application is granted, hence this transfer does not fall in the category of financial burden on state exchequer under rule 42 of Chapter-IV of F.H.B. Volume-III.

(6) Further, in compliance of Hon'ble Supreme Court's order dated 11.07.2023 passed in Writ Petition(Civil) no. 699/2016 Ashwini Kumar Upadhyay vs Union of India, it is submitted that, though the applicant is currently posted in MP/MLA Court, but no such case is pending in my Court at any stage. There is zero pendency of cases related to MP/ MLA in my Court. Hence there is no such bar to grant my request if the Hon'ble Court so pleases.

Respected Sir, it is therefore, my most humble prayer to your good offices that my this representation may kindly be placed before the Hon'ble Court for kind and sympathetic consideration for which I along with my family shall remain highly obliged to Hon'ble Court for the rest of my life.
