Subject: Request for transfer on medical grounds.

With due reverence, it is most humbly and respectfully submitted for the Hon'ble High Court kind consideration:

1. That the undersigned is presently posted as Civil Judge (Junior Division) at District Court Bareilly from 2018 U.P. Judicial Services Batch. It is further submitted that the undersigned is afflicted with the chronic disease **Diabetes type-I (4 times Insulin dependent in a day)** since past 12 years.
2. That due to the above stated reasons, the undersigned has been through the various complications such as Cataract ailment in both eyes, hemolytic anemia(distorted Iron Binding), hypoglycaemia, nausea for which the undersigned was congruously visiting the local district and private hospitals at Bareilly. Most of the times, **the undersigned did not get diagnosis with the actual complication at local district and private hospitals** and thereby, on account of some aggravated side issues, the undersigned helplessly ended to visit AIIMS and LNJP hospital at New Delhi every time for her due care and expedite treatment.
3. That, currently, the undersigned is under regular care and treatment of the doctors at **Lok Nayak Jai Prakash, New Delhi, All India Institute of Medical Science, New Delhi at Endocrinologist, Ophthalmology, haematology and Medicine department.** That the undersigned has been under regular supervision and inspection of her concerned doctors following up her routine check-up.
4. On account of afore-stated health issues, it was also advised by the concerned doctors at AIIMS and Bareilly to keep in regular consultations and investigation with the doctors at Delhi situated Hospitals for a proper inspection for my illness reflecting through some complications. However, on account of short of leaves and some times frequent travel to Delhi and also

some times, not able to get there sufficiently on time interval. the undersigned is facing difficulties in managing her health issues.

5. That the undersigned is very much concerned and worried for her medical conditions. Without taking any risk or compromise, *where health is all the foremost and utmost prior consideration for any human wellbeing in all the spheres of her life, it leaves no choice to undersigned (or to any person) but to take utmost due care and sincere consideration towards physical, mental well-being and also the professional well-being under the routinely and strict supervision of her doctors.*
6. That the undersigned has enclosed her all medical reports and papers of her undergoing treatment particularly at AIIMS, Delhi and Lok Nayak Jai Prakash Hospital, New Delhi as annexures for Hon'ble High Court kind consideration and necessary perusal.

Prayer

In view of the abovementioned facts and circumstance, It is humbly and respectfully prayed to the Hon'ble High Court that the Hon'ble High court may kindly be generous to transfer me from the Judgeship of Bareilly to Judgeship close or near to Delhi.

For this act of generosity, the undersigned shall always be grateful to the Hon'ble High Court.
