## **Sub:-** Application for extention of time period of Posting(Stay)

Respected Sir,

Respectfully it is submitted that I, Preeti Moga have been posted at Hapur as ACJM 1<sup>st</sup> by the Hon'ble High Court order Notification no. 1177/Admin/Services/2021 dated 09.04.2021. I assumed the charge on 13.04.2021. Thereafter, I was posted as CJ(SD)1st at the present station by the Hon'ble High Court order Notification no. 2620/Admin.(Service)2023, dated 18.11.2023. Where I took the charge on the 21.11.2023. Sir, I'm mother of two children(Son age 4 years and Girl of 2 year 6 month). Both children are suffering from medical problems. Son(Shree Bhardwaj) has been diagnosed with Epilepsy when he was around 8 months and the child is undergoing treatment under the expert supervision and guidance of Dr. Veena Kalra (Neuro Surgeon), AIIMS retired at New Delhi. During the treatment it come to light that my son is also suffering from MILD AUTISM. I beg to submit the treatment and (Occupational Therapy, Speech Therapy, Educational Therapy, Phisiotherapy, Hearing Impaired Therapy) were advised. The Therapies nearest place are available at Ghaziabad, Meerut, Greater Noida, New Delhi. Last year, in the month of January 2022 my child had severe and uncontrolable seizure (Epilephic) attachs which his therapies, due to from District Hospital Ghaziabad had to be stopped in the midway. Now in the recent visit for further treatment to Dr. Veena Kalra(Neuro Surgeon), she emphasied the need for treatment and the theraphy to improve the delay developments of Son.

My daughter(Siddhi) is also suffering with the problem of motor delay consequently she is not able to walk on her legs and her speech are not meeting the milestones as per her age. My daughter (Siddhi) also requires the physio therapy and speech theraphy for which I am getting her therapy at Hapur and Bulandsahar from Ayurvedic Doctor (Vaid). With Great diffculty me and my children have been able to adjust and now comfortable with their Doctors who are providing the treatment and children are responding to their treatment. The timing of my transfer is likely to pase significant interuption in their treatment and therapy. They need continuous suspension of their Doctors which would not be possible if the applicant transfer to any other District. In this emergent situation the applicant seek the kind permission and sympathitic consideration of Hon'ble Court to get her transfer stayed.

I'm enclosing medical records for the kind presued of the Hon'ble Court.

Applicant again retierats her request that her case be taken up sympathically by the Hon'ble Court for which applicant shall always remain greatfull.
