

DIAGNOSIS: REFRACTORY RHEUMATOID ARTHRITIS WITH POST - LAMINECTOMY SYNDROME

CO-MORBIDITY; HYPERTENSION

BRIEF SUMMARY OF THE CASE

61 YR OLD FEMALE PATIENT IS KNOWN CASE OF HYPERTENSION AND REFRACTORY ARTHRITIS WITH POST LAMINECTOMY SYNDROME WITH B/L SACROILITIS.

SHE UNDERWENT MIPSI PROCEDURES IN OCTOBER 2022 FOLLOWED BY CATHETER INSTILLATION RFA IN JANUARY 2023.

SHE NOW PRESENTED TO THE EMERGENCY OF RAJIV GANDHI CANCER INSTITUTE AND RESEARCH CENTRE WITH SEVERE PAIN IN LOWER BACK PAIN (VAS AT PRESENTATION - 8/10). PATIENT IS UNABLE TO CARRY OUT ROUTINE ACTIVITIES DUE TO PAIN.

PATIENT AND BYSTANDERS WERE COUNSELED IN DETAIL REGARDING NEED FOR ADMISSION, ANALGESIC DOSE TITRATION (INTRAVENOUS) AND NEED FOR REPEAT NERVE BLOCK PROCEDURES (MIPSIs).

BLOOD WORK ON ADMISSION SHOWED PT/INR - WNL, CREAT - 1.26, ALB - 3.86.

SHE WAS STARTED ON SUPPORTIVE CARE WITH IV FLUIDS, RESPITE CARE, IV ANTIBIOTICS, IV ANALGESICS -ANALGESIC DOSE TITRATION AND INJ DENUSUMAB S/C. THE PATIENT AND BYSTANDERS WERE EXPLAINED IN DETAIL REGARDING THE POSSIBILITY OF FAILURE OF BLOCK (MIPSIs) AND AFTER WRITTEN INFORMED CONSENT THE PATIENT WAS TAKEN UP FOR NERVE BLOCK PROCEDURES (MIPSIs) WITH RFA ON 23/11/2023. PATIENT TOLERATED THE PROCEDURE WELL - VAS POST PROCEDURE 2/10.

SHE WAS ALSO GIVEN DESENSITIZATION DRIP ON 24/11/2023 AND 25/11/2023 WHICH SHE TOLERATED WELL AND IS NOW BEING DISCHARGED IN STABLE CONDITION.
