Subject- Request for Pre-mature transfer

Respected Sir,

It is humbly submitted that I have transferred to Balia from Kasganj by the notification dated 18.11.2023. I am requesting for my premature transfer to a district adjoining my home district Amroha for the following reasons-

- 1) My father met with a road accident 4-5 months ago, and he had knee fracture. He was on bed rest for a long time. Even now he is not fully able to attend the normal functions of life, and he is still going through treatment. There are only four members in my family- mother, father, me and my younger brother. My younger brother is only 20 years old and he lives in Delhi as he is taking coaching for the MCA examination. Therefore, there is no other family member who can take care of my father. Further my father is also a patient of sugar and high blood pressure, which makes his problem more severe. Therefore, if I am posted near Amroha then I will be able to help him out in his treatment. I am attaching medical papers of my father.
- 2) My mother has been suffering from the problem of migraine, and she is having severe headaches due to that. Currently my mother is going through treatment of some dental problems from AIIMS too, and it would need some minor surgeries. As, my father is himself having knee fracture, and my younger brother is taking coaching so there is no family member who can take care of her.
- 3) I even filed a representation last year on this ground of my mothers' health and requested a posting near Amroha, but the same was not entertained, and I was given a posting in a district which is farthest from Amroha.
- 4) In administrative decisions too the considerations of justice and compassions may be taken into account. From Ballia it is extremely difficult to visit my hometown Amroha or even to help my parents in their treatment. Further I would be required to travel a lot and take frequent earned leaves.
- 5) I have filed a case against one woman Kawaljeet Kaur, who is a professional extortionist in the District Kasganj. Other officers have also filed cases/complaints against her. Being the complainant, it is very difficult to attend to the case from Ballia as it is 700 km away from Kasganj.

- 6) In all the adjoining districts of Amroha which are Moradabad, Bijnor, Meerut, Hapur, Sambhal, seats are vacant, so there was/is no administrative difficulty in giving me a posting in any of these districts.

At Kasganj district I was the only judge in the junior division who had completed his action plan, and my units were also 1890 units which were way above the required units criteria of 1200 units. I am a hard working, efficient and honest officer. With all these reasons, for the sake of my parents, who have made me capable of becoming a judge, I humbly request you to allow me a transfer to the adjoining districts of Amroha (i.e. Moradabad, Bijnor, Meerut, Hapur, Sambhal).

I would be highly obliged by your kind act.
