Respected Sir,

Subject: Application for premature transfer from Bahraich along with my spouse on the ground of spouse in service and the medical condition of paralytic mother-in-law.

With due regards, it is most humbly submitted that the undersigned is posted at Bahraich since 28/04/2023 and is currently serving as Civil Judge (Jr. Div.), Bahraich. My spouse Arun Yadav (JO Code UP3499), is at present serving as Civil Judge (Jr. Div.) FTC Crime against Women, Bahraich.

It is most humbly submitted before your goodself that my mother-in-law, Smt Champa Yadav aged about 60 years, had suffered from stroke and paralytic attack in the year 2018 and again in August of 2023. Due to recurrent episodes of stroke and paralytic attack my mother in law is completely bedridden and is in constant need of good medical care and frequent visits to hospital. The documents with respect to my mother-in-law's medical treatment are enclosed with this application for kind perusal of your good self. It is my humble submission that my father-in-law is a retired senior citizen and my spouse is the only earning son in his family. At present my mother in law is undergoing treatment for her condition at Aligarh, Uttar Pradesh, which is approximately 600km away from Bahraich. It is further submitted that, there is no direct mode of train connectivity between Bahraich and Aligarh and journey via road from Bahraich to Aligarh takes approximately 11 hours. It is my humble submission that, for the above-mentioned reasons my current posting at Bahraich is posing great hardship before myself and my spouse in discharging our familial duties. In addition to this I am a mother to a five months young baby boy (documents enclosed) due to which it is even more difficult for me to manage frequent visits to Aligarh for medical treatment of my bedridden mother-in-law and is difficult for myself to reside alone at my current place of posting. It is for the aforesaid reasons that my current place of posting at Bahraich is causing me a great deal of mental distress. My spouse as mentioned above has also represented before the Hon'ble High Court of Judicature at Allahabad for premature transfer on the ground of medical condition of his bedridden mother. It is most humbly submitted that my request for premature transfer along with my spouse be entertained on the ground of the medical condition of my mother in law and the ground of spouse in service. It is my humble request that the undersigned and her spouse Arun Yadav (JO CODE UP3399), be kindly transferred to a place in close proximity to District Aligarh, Uttar Pradesh.

It is humbly prayed that my representation for premature transfer from Bahraich to a place in close proximity to District Aligarh be placed before Hon'ble High Court to be considered on ground of medical condition of my paralytic mother in law and the ground of spouse in service.
