With reference to the subject cited above , I most humbly submit the following for your kind consideration and sympathetic action :

1. I have joined the judicial service pursuant to Hon'ble High Court's Notification No.67/Admin.(Services),2017 Dated 11.01.2017 as Additional Civil Judge (J.D.) on 13.01.2017. I am presently posted as Additional Chief Judicial Magistrate , Court No. 1 in Mirzapur district.
2. **My marriage has been solemnized on 19.11.2019 with Shri Anupam Singh, who is serving as Assistant Commandant in Central Reserve Police Force and presently posted at Varanasi ,Uttar Pradesh.**
3. My husband is presently residing at Varanasi along with my old father in law and mother in law. **My mother in law Smt. Suchita Singh is cancer patient and undergoing treatment and regular follow up from Homi Bhabha Cancer Hospital, Varanasi since October, 2019.** She has to be taken up to the Hospital for routine check up regularly. Due to such deteriorated health condition my mother in law needs constant medical care and emotional support. My husband has no sibling, so prime responsibility to look after my in laws lies on both of us, also he can't spare much time for his

6. Varanasi and Mirzapur are adjoining districts and in any case of emergency it is easily reachable for both of us. Stay of my transfer will make it very convenient for both of us to perform our professional as well as personal duties.

In view of the above elucidated facts ,I most humbly request that the matter with my prayer for stay of transfer(at Mirzapur) for year 2024 may kindly be placed before the Hon'ble High Court for kind consideration . I shall be highly obliged if my request for stay of transfer from Mirzapur would be considered sympathetically.
