Respected Sir,

I have the honour to express my earnest request for an extension of my tenure at Lakhimpur Kheri and place following facts for kind consideration of the Hon'ble Court:

1. That, in compliance with the directives outlined in the Hon'ble Court's notification no: 1391/Admin.(Services)/2021 dated 12.04.2021, I took the charge of the office of the Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Lakhimpur Kheri ON 16.06.2021
2. That, on the latter date, as per notification no. 1814 dated:01.07.2021, I have taken the charge of Secretary, DLSA, Lakhimpur Kheri and diligently discharged my duties until 03.07.2022.
3. That again as per notification no- 925 Dated: 03.07.2022 I was transferred to my current position. Since then, I have been actively fulfilling the responsibilities of Additional Civil Judge (Senior Division)/Additional Chief Judicial Magistrate, Lakhimpur Kheri.
4. That, I am scheduled to complete a three-year normal tenure of posting at Lakhimpur Kheri on 11.04.2024. However, considering my personal circumstances, I seek Hon'ble Court's compassionate consideration in this matter.
5. That, my hometown is Lucknow district, and my close family members and blood relatives resides in Lucknow and Agra.
6. **That, at the moment, I am the sole caregiver for my three-year-old son(Divit Singh- age 03 yrs.) who was born in the year 2020 (Birth certificate attached below). In addition to my parental responsibilities, my aged father resides with me. Given his health condition, he frequently requires routine and emergent**

medical check-ups and treatments. My father plays a crucial role in supporting me with childcare, especially during my duty hours in the office/court.

7. That, I wish to bring to Hon'ble Court's attention that a transfer at this juncture would pose substantial inconvenience to both myself and my child.

Therefore, I respectfully request that Hon'ble Court be kindly moved Hon'ble Court for kind consideration and seek approval for an extension of my stay at Lakhimpur Kheri for another year.

I shall be highly thankful and obliged for your understanding and consideration in this matter and assure you of my continued commitment to fulfilling my duties with utmost dedication.
