DISCHARGE SUMMARY

**Treatment given during hospitalization:**

Patient was admitted under supervision of Nephrologist with complaints of sudden onset nausea, dizziness, 2 episodes of syncope around 1-2 hour prior to admission, history of iron infusion done same day of admission, generalized weakness, decrease appetite on and off, shortness of breath on moderate since 10 - 12 days. After initial treatment patient was shifted to MICU for further management. Required investigations were done during hospitalization. ECG was done. Hb - 9.80, TLC - 18.18, Creatinine serum - 1.32. USG whole abdomen suggestive of Bilateral small sized kidneys with medical renal disease. ECHO was done which revealed LVEF - 60%. Mild Tricuspid regurgitation, NO PAH. Mitral, Aortic and Pulmonary valves are normal, Normal RA/RV size & Function. When patient was symptomatically better she was shifted to ward. During hospitalization patient was put on Inj Covinem TZ, Inj Espra, Inj Emeset, Inj Transfer, Tab Nodosis DS, Cap Contaflix, Tab Nefrosave, Cap Ubiglu, Tab Irovap, Tab Renolog and other supportive treatment. Today patient is being discharged in stable condition.


