PARENTS TO NOTE

The suggested schedule may be modified by your doctor as per the need.

Immunization can be given in the presence of minor illness.

Prior to immunization, inform your Doctor if the child has had any significant reactions to the last dose.

BCG

A nodule appears 3-4 weeks after BCG vaccination. It may soften or ulcerate in 2-4 weeks. No application or fomentation is necessary. It heals, leaving a scar, indicating effective vaccination.

DPT

There may be mild fever and pain, redness and swelling at the site of injection. A small painless lump may remain for a few weeks. For fever and pain, paracetamol syrup/tablet may be given. The dose can be repeated every 4-6 hours if required. Please consult your Doctor for any other reaction.

Measles / MMR

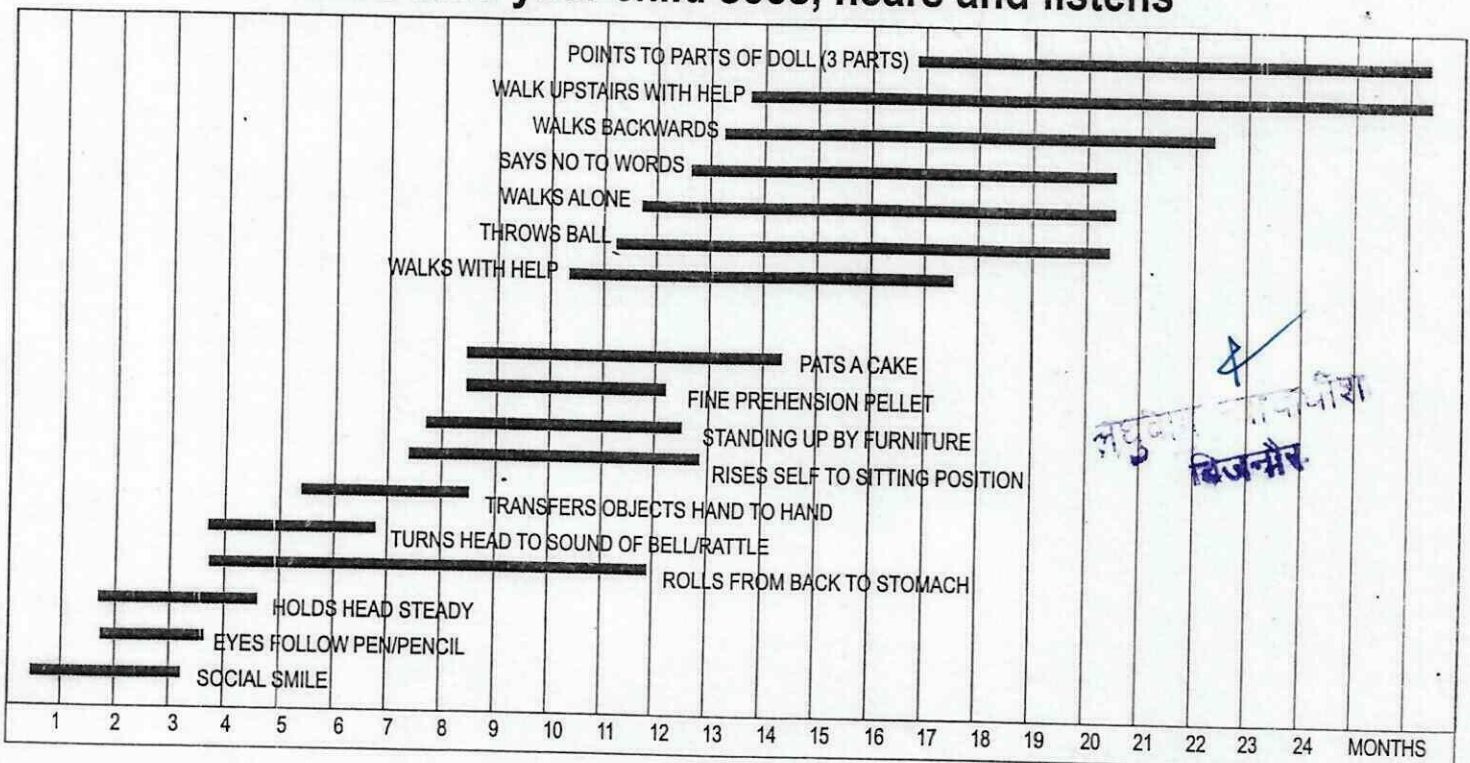
A few children get fever 4 to 10 days after the vaccination. Paracetamol syrup/tablet may be given if required.



Clinical Transcript of Ms. Zehra, Registration/File No. 1333 as on 18 November 2017

Report 1 (Observation, Assessment & Intervention Plan)

Ms. Zehra D/o Mr. Sharib Ali, aged 3 years and 6 month came to this centre on 13th January 2016 with complaints that:

- she was not able to follow instructions;
- she did not like changes; and
- dependent on self help skills on parents.

It was also reported that as she failed to speak; parents consulted professionals and were told that their child had autism spectrum disorder.

She was under observation for few sessions and found to have very poor 'on seat behaviour', no eye contact and attention and concentration were to be very inadequate. She did not respond to her name and she had hyperactive behaviour with speech which was almost absent.

Zehra was also assessed/screened for autism on M-Chat. On the aforesaid tool, she was found positive on these observable behaviours:

- Does not take interest in other children.
- Child likes climbing on things.
- Does not enjoy playing hide & seek.
- Child has no eye contact.
- Does not imitate.
- Child does not respond to her name.
- Child does not look at things, you are looking at?
- Child does not attract her parents attention with her activity.
- Child does not understand what people say.
- Child does not look at your face to check your reaction when faced with something unfamiliar.

Therapeutic sessions were planned with focus on: (i) developing communication skills; (ii) developing social/interpersonal skills; (iii) increasing eye-contact and attention; (iv) developing skills of cognition, self care, etc. Intervention was provided with several structured and semi structured activities of mostly one to one sessions and few group sessions.


