Subject:- Representation regarding pre-mature transfer from District- Lucknow to any District adjoining Agra/Delhi/NCR

Respected Sir,

With due respect, the undersigned most humbly submits as under-

- (1) That the undersigned was transferred from the post of Chief Judicial Magistrate, Farrukhabad to the post of Judge Small Causes Court, Lucknow vide Notification No. 2705/Admin. (Services)/2023 Dated: Allahabad: November 18, 2023. Thereafter, in compliance of the aforementioned notification , the undersigned took over the charge as Judge Small Causes Court, Lucknow on 24/11/2023.
- (2) My spouse Smt. Ratna Pandey belongs to District-Lucknow. She received her education at all levels from educational institutes of Lucknow. She pursued her University Education from University of Lucknow. Her near and distant blood relatives and friends are also residing in Lucknow. Few of her relatives are also in legal profession and practice law in District Court – Lucknow.
Judge should perform the duties of the Office fairly, impartially, diligently and in unbiased manner. The duties of judicial office takes precedence over all other activities. Factors indicated above may adversely affect in performance of my pious duties.
- (3) My old aged parents are permanently residing alone in ancestral home at District- Agra. My father is currently aged 77 yrs and mother is aged 71 yrs. Both of them are suffering from many serious ailments. The undersigned is the only son of my parents. There is no other family member to take care of them.
- (4) My mother Smt. Rani Tyagi is suffering from various serious diseases like Diabetes, Osteoporosis, Rheumatoid Arthritis, Knee & Shoulder pain, Joint pain etc. and find it very difficult to perform her own daily chores.
- (5) My father Shri Pooran Kant Tyagi met an accident in May, 2015 in which serious brain injuries were caused to him. This has led to imbalance of sense in him and requires frequent visit of doctors for continued medication. He is also suffering from other ailments like Diabetes, Hepatomegaly, Prostatomegaly etc.
- (6) Medical treatment documents of my mother Smt Rani Tyagi & Shri P.K.Tyagi are duly attached herewith as “ Annexure- 1 & 2”, respectively.
- (7) My parents are deeply attached to their ancestral roots and inspite of repeated requests, they are not ever willing to re-locate and live happily with me, whereby I can easily undertake their medical requirements at local level. The undersigned is also required to fulfill the moral obligation towards parents in their old age. On account of serious ailments of my parents, the undersigned is required to make frequent visits to Agra for medical purposes, which entails spending valuable time, energy and finance. Recently, doctors have advised me to undertake their advance care treatments in some Multi Super Speciality Hospitals like Medanta Hospital,

Gurugram or All India Institute of Medical Sciences, New Delhi, so that all medical facilities are available to them under one roof. This has necessitated me to undertake their advance treatments in such Multi Super Speciality Hospital, near Delhi, which will further require me to make frequent travel to Agra/Delhi and spend valuable time, energy and finance. In order to focus better on my judicial duties and responsibilities, it is very essential that the undersigned may be transferred pre-maturely from District-Lucknow to some other district adjoining Agra/Delhi/ NCR.

I, therefore, very humbly request you to kindly place my representation before the Hon'ble Court for kind and sympathetic consideration of my transfer from District-Lucknow to any district adjoining Agra/Delhi/NCR, so that I can fulfill my moral duty towards parents of providing world class medical facilities in their old age. I shall be highly obliged and ever remain beholden.
