- (a) That is, I have been **suffering from complexity of HYPERTENSION, Thyroid disorder and acute Diabetes ailments and** needs family support at times of high anxiety and stress (treatment prescription attached).

- (g) That is, Etawah is approx 350 km from Delhi and is not easily approachable place, due to my critical ailments sometimes I suffer psychological stress (Headache and anxiety) that compels me to go to my family urgently.
- (h) That I would also like to inform you that **my retirement is due in December 2024 and change of posting suitably will help me for settlement in retirement year i.e 2024.**
