 I most respectfully beg to state that during the Annual Transfers notified on 13.04.2024 by the Hon'ble Court, I have been transferred from Rampur to Mirzapur Judgeship.

2. That my wife Mrs. Jyoti Rai Tripathi is suffering with many health issues detected by doctors in AIIMS, New Delhi as Pulmonary Artery Hypertension and Dialated Right Side of her Heart, Osteo Artheritis, Vericose Veins in both the legs.

3. That during 2018 to 2021, while I was posted in Meerut Judgeship, which was near to AIIMS, New Delhi and My wife was under the treatment for the same in AIIMS till Covid first wave 2020 occured. Since then she was in continuous line of treatment of Dr. Jitendra Tyagi, (Chest Specialist, Bronchoscopist) in Meerut along with AIIMS as well.

4. That I got transferred to District Rampur in year 2021 and was posted there from 13th April 2021 to 15th April 2024. From Rampur distance to AIIMS, New Delhi and Meerut was just 200 kms, which was easy to remain under the treatment and follow up with Dr Jitendra Tyagi in Meerut as well as AIIMS, New Delhi

- That during COVID-19, my family was in Lucknow. We could not consult at AIIMS, New Delhi, so she was refferd to SGPGI, Lucknow and received treatment there for the same disease.
- 6. That since passing of time her condition is getting deteriorated and as of now I have been trasferred in Annual Transfer notification dated 13-04-24 to Mirzapur District, where no such appropriate medical facility is there for such chronic diseases. Secondly my daughter who is 5 years old needs my presence around her to be taken care of.
- 7. That with so many ailments of my wife it would be very difficult to be taken care of her treatments in Mirzapur. As her continous treatment would not be possible from Mirzapur which is approximately 750 kms away from AIIMS, New Delhi as well as Meerut. It has become quite difficult for me to come to Delhi as well as Meerut to continue the treatment without any breakage.
- 8. That in support of the statements above, the undersigned has annexed photocopies of the medical records of my wife with this application.
- 9. It is, therefore, folded handedly prayed that the Hon'ble Court may very graciously be pleased to transfer me from my present place of posting at Mirzapur to any of the districts nearer to AIIMS, New Delhi / SGPGI, Lucknow. I and my ailing wife shall remain extremely grateful to the Hon'ble Court for this grace throughout our life.
