Sub: -Request for premature transfer due to mothers' cancer treatment at AIIMS Delhi & spouse posting

R/Sir.

Respectfully, I wish to submit that the applicant's mother is currently battling cancer. She has already undergone two surgeries and is currently undergoing chemotherapy at AIIMS Delhi. As per the doctors' advice, my mother regularly visits AIIMS Delhi for her treatment sometimes fortnightly or weekly. I had requested hon'ble High Court to grant me permission to remain stationed in my previous station Baghpat for one more year, due to my mother's ongoing critical treatment at AIIMS Delhi & spouse posting.

Within my family, I am the sole individual capable of tending to my mother's needs. Last year in 2023, my father passed away due to brain hemorrhage. My elder sister resides in Vadodara, Gujarat, with her husband, where she shoulders the responsibility of caring for her 85-year-old ailing mother-in-law. I have a younger brother who is currently preparing for competitive examination and is not financially independent yet.

Given these circumstances, I cannot shirk my family responsibilities. Even though I may live miles away, I will take care of my ailing mother to fulfill my family responsibilities.

The applicant's request for stay was not granted favorably, resulting in transfer to Shahjahanpur. Applicants husband is presently posted in TRAI Delhi till 2025 on deputation. The applicant could have balanced both her family responsibilities and judicial work duties, if stay application at Baghpat would have been allowed, ensuring justice to both aspects of her life.


The distance from Shahjahanpur to AIIMS Delhi is approximately 400 kilometers. Given my mother's condition, it's not feasible for her to frequently travel such a long distance for her treatment, often 2-3 times in a month. Applicant shall be compelled to take frequent leave from work affecting judicial work.

Given these circumstances, the applicant wishes to respectfully request the hon'ble high court to show mercy and transfer her to any place within close proximity to AIIMS Delhi to get her mother properly treated to save her life & stay near her spouse. As The applicant is under the protection and Guardianship of hon'ble High Court, therefore, applicant is submitting a request to hon'ble High Court to consider her plea on humanitarian ground and grant her permission for premature transfer from Shahjahanpur to any place near AIIMS Delhi .

For this, I shall be highly obliged & grateful to you.
