## Request for premature transfer near Delhi on grounds of serious health issues with my spouse.

- 1. With due respect, I wish to state that I am presently serving as Civil Judge Senior Division First, Basti. My wife, Tanu Priya Jaiswal, is facing serious health issues i.e., deep infiltrating Endometriosis, Adenomyosis, Hydrosalphinx, Adenomyoma and other issues related to reproductive organs which is severely affecting the vital organs of her body resulting in deterioration of quality of life.
- 2. In February 2020 she felt excruciating pain in her abdominal area. After consulting a few doctors we went to AIIMS Delhi, where she was advised to undergo an immediate extensive and critical surgery. As we were processing, the first Covid 19 Lockdown came into force. Due to the lockdown, AIIMS as well as other doctors were not ready to perform the surgery. A major surgery was done on July 4, 2021 at Max Saket, New Delhi wherein Laparoscopic Management of Endometriosis with Removal of Bilateral Endometriomas with Left Salpingectomy with Excision of Endometriotic Nodule with Diagnostic Hysteroscopy with Adhesiolysis was performed.
- 3. But even after the surgery, the disease reoccurred earlier than doctors could predict, which resulted in no substantial relief post surgery. Presently, she is undergoing treatment at Max Saket, Delhi as well as Fortis La femme G.K New Delhi, as doctors from major cities refuse to take up her case considering the gravity of her medical condition. The results of carcinogenic indicators like CA-125 and CA-19.9 are quiet high above normal range in pathological tests and as per ultrasound and MRI reports my wife is still suffering from multiple fibroids in uterus measuring 66X58X50 mm, 53X18 mm, 25X24 mm and 27X27 mm; right ovarian cyst measuring 29 mm, 26X25 mm, 24X25mm 19 mm; left ovarian cyst 31X31 mm and right side fallopian tube hydrosalpinx 54X20 mm. This state of health requires constant medical attention and frequent visits to healthcare facilities.
- 4. As per the Advice of doctors we proceeded with IVF treatment at Sir Gangaram hospital, New Delhi. In two attempts of the procedure doctors could fetch only one embryo and her disease grew further. Now we are advised to go for surrogacy and we received the Certificate for the same from Director IVF lab Sir Ganga Ram Hospital, New Delhi on 27 March 2024. Now we are in the process of applying for permission of surrogacy at the Directorate of Family Welfare, NCT New Delhi.
- 5. According to the new Surrogacy Regulation Act, 2021, surrogacy in India has been regulated wherein the centres performing surrogacy procedure have to be authorised from the prescribed authority. Sir Ganga Ram Hospital has received the authorisation for the same recently. Considering the latest developments in surrogacy law and the ongoing process of surrogacy and treatments being conducted at New Delhi, it has become extremely challenging for me to fulfill my professional duties effectively while also ensuring her well-being from my present place of posting at district Basti which is around 775 km from Delhi.

- 6. As per diagnosis, this Disease has spread to all the organs of Abdominal area and the organs have got stuck together. Therefore, there is again an urgency of more extensive surgery.
- 7. Being married for 7 years, still we do not have any child. In this kind of medical situation, we do not have a lot of time to prolong the treatment. Doctors have already adviced for complete removal of uterus as soon as the surrogacy procedure starts. So we are struck in the web of medical treatments. Given the gravity of her illness and the ongoing process of surrogacy and treatments being conducted at New Delhi, it has become extremely challenging for me to fulfill my professional duties effectively while also ensuring her well-being from the current place of posting i.e., Basti. Delhi, being the national capital, boasts some of the best medical facilities and specialized doctors, which would significantly improve the chances of her recovery.
- 8. Therefore, I humbly request you to consider my plea for premature transfer application from my current place of posting to a location near Delhi due to my wife's critical medical condition so that I can start my family.

Kindly place my premature transfer application before Hon'ble High Court for consideration on humanitarian grounds. I will be highly grateful to you.
