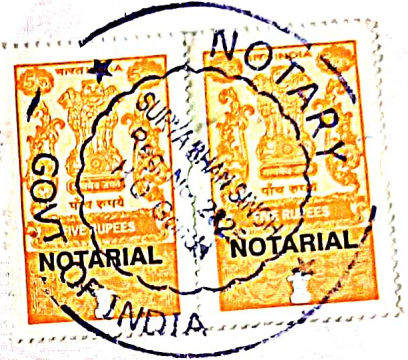
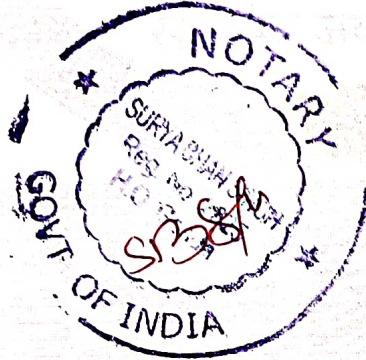
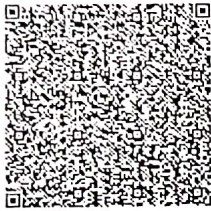

AFFIDAVIT

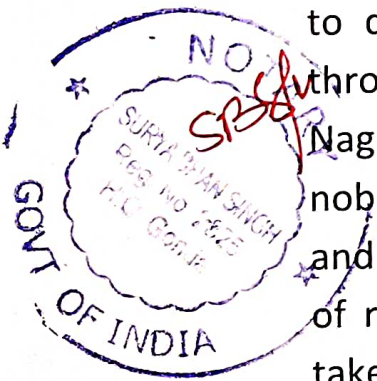
I, Lalit Singh, Son of Shri Mahabir Singh, age -33 years, Resident of House No.-974 Sector-43 Golf Course Road Gurugram-122002, do hereby solemnly affirm and state on oath as under:

1. That the deponent has been transferred from LARRA Kanpur Nagar to Gonda vide Hon'ble High Court's Notification No.1369/Admin. (Services)/2024 dated 13.04.2024 and in pursuance of Hon'ble High Court's Notification deponent has joined as Addl. Civil Judge (Junior Division) Gonda in the morning of 16.04.2024.

2. That the deponent's wife Smt. Anchal Chaudhary is Posted as Senior Assistant in Reserve Bank of India, Kanpur Nagar which is an Autonomous Body under Government of India and the post of Senior Assistant in RBI is NonTransferable. (Last Month's Salary Statement and ID Card of Smt. Anchal Chaudhary is enclosed).

3. That the deponent's wife Smt. Anchal Chaudhary gave birth to deponent's first son Ojas Lalit Chaudhary on 17.02.2024 through C- Section Operation in Regency Hospital, Kanpur Nagar and deponent's son is only 2 months old and there is nobody apart from deponent to take care of deponent's wife and son in Kanpur Nagar. Deponent's wife is still in the process of recovery after C-Section operation. She is alone unable to take care of deponent's two month son. All the postpartum treatment of deponent's wife and son are undergoing in Kanpur Nagar. (Discharge Certificate of Deponent's wife and Birth Certificate of deponent's son is enclosed).

4. That the deponent is presently posted in Gonda due to which deponent is not in a position to look after his wife and newly born son at this juncture of Life. It is not possible for deponent to reach Kanpur Nagar in time in case of any emergency relating to deponent's wife and son.



5. That the deponent had earlier no opportunity to submit the transfer application or apply for stay via Eservices Portal because the application for applying in Annual Transfer-2024 was not opened as deponent was transferred in LARRA Kanpur Nagar on 15.07.2021 and the deponent's transfer was not due this year as per criteria having 3 year completion in the District Headquarter on 31.05.2024 mentioned in Hon'ble High Court's Circular Letter No.- 28/Admin. (Services)/2023, Dated September 30, 2023.

6. That the deponent swears that the content of this affidavit are true and correct.
