Subject : Representation regarding pre-mature transfer.

Respected Sir,

With all due respect, it is to bring to your kind notice that I have been presently posted as Addl. Principal Judge Family court, Bahraich vide Hon'ble High Court's notification number : 384 / Admin. (Services) / 2022 Dated: Allahabad : July 3rd , 2022.

I want to put forward for your kind consideration that I have severe health problem since 28th January 2023. I have consulted many doctors finally they referred to the Cardiac and Gastrology Department of SGPGI Lucknow. During investigation in Cardiology Department SGPGI, Lucknow it is found that I have been suffering from a disease called **Cardiomyopathy/Global Hypokinesia and LV Dilation** having Ejection fraction of only 25% which termed as **Critical heart failure**. Which need's close monitoring under regular supervision of specialist doctor's. Doctor's also advice me not to take exhortion otherwise it will adversely effect the cardiac health specially Ejection fraction which may resulted in complete heart failure. They also refer to the Urology Department where diagnosis is under progress for which date has been provided. During investigation it is found that **in Right Kidney Moderate Hydronephrosis** is noted, Prostat is enlarged and **in Gall Bladder 16 mm calculi/stone** is also found. The doctors of Eurology department also advised for further tests and consultation in Pulmonary and Gastrointestine Department. All these conditions need's regular visit to SGPGI Lucknow but for regular visit my cardiac health condition does not permit me. Consultation in these departments are still pending due to distance factor. Such facilities are only available at SGPGI Lucknow or AIIMS New Delhi or MEDANTA Hospital Gurugram, Haryana.

Therefore, I most humbly request to Hon'ble Sir to take notice of the above aspect and for treatment, care & good health kindly consider my transfer request for Lucknow or nearest station to New Delhi wherever the Hon'ble Court wishes.


- 1- That I have been suffering from a disease called **Cardiomyopathy / Global Hypokinesia with diffuse wall thinning and LV Dilation.**


