Sir,

Most respectfully, it is humbly submitted that in the Annual Transfer 2024, I have been transferred to Fatehpur Judgeship as Addl. District & Sessions Judge. This is my second posting in judgeship Fatehpur. Previously I had been posted in this judgeship in year 2015. In the process of promotion, at that time, I was transferred to District Prayagraj (Allahabad). So I am well aware of the difficulties & problems, in this district. In District Fatehpur. Judicial Officers have to face problems of poor medical facilities and other problems related to Basic necessities of life.

Presently my wife Mrs. Alka Gupta is having pregnancy of about 6 months. This is a very pleasant development for our family. We couple currently have only one child. We are expecting birth of our second child in middle of August 24. My wife is aged about 40 years, thus very sensitive Case for safe & healthy pregnancy and delivery.

Presently my wife Mrs. Alka Gupta is receiving medical treatment and advice/counselling from Gynecologists of District Kanpur Nagar & District Bareilly, where I was posted previously .

In the month of January & February 2024. some serious problems occurred in my wife's Embryo/Fetus , for this Medical treatment and Genetics Dygnosis was done in Sir Ganga Ram Super Specialities Hospital, New Delhi. Presently She is also receiving Medical Treatment and specialist Counselling from Dr. Manju Sinha ,Senior Consultant Gynecologist, Disttrict Noida and Dr. Ratna Dua Puri Senior Consultant & Professor in Genetics/ Chairperson, Institute of Medical Genetics & Genomics Sir Ganga Ram Hospital New Delhi.

My first child Atharv born in Allahabad in August 2016. It was a premature birth. At the time of his birth , Atharv was suffering from problems of low immunity and serious infection of

Respiratory Tract . Thus, Atharv was hospitalised in Neo Natal Intensive Care Unit (NICU) of Hospitals of Allahabad for 11 days. After hectic efforts of Various Senior Pediatricians of District Allahabad (Prayagraj), his life could be saved. Later on I arranged high level medical treatment of my son in various reputed Hospitals of District Prayagraj (Allahabad) , Kanpur Nagar and Ultimately in Medanta Medicity Gurgaon.

Thus at the time of delivery of my wife, very intensive medical supervision and Advanced medical facilities are required. But such high level medical facilities are not available in District Fatehpur . Having posted in Fatehpur, in case of any emergency of other miss happening incident, It is very difficult to arrange the medical treatment for my wife and new coming child .


Though there is a Medical College in Fatehpur District, but buildings are underconstruction and so called Medical College is operational on papers from District hospital Fatehpur. After 8 P.M., No specialist Doctor is available in Fatehpur town, as most of them reside in Kanpur Nagar or Prayagraj.

In above mentioned facts and circumstances before me, for safe & healthy Delivery of my wife and wellbeing of my new coming child, if I may kindly be transferred and posted in any District/City having Advanced Medical Facilities/Super Specialities hospitals, in western Uttar Pradesh, near New Delhi, It will be very helpful for me & my family In obtaining Intensive Medical treatment and counselling for my wife and my new coming child.

It is, therefor, most respectfully prayed that my humble request, for Premature transfer and posting in any District /City having Advanced Medical Facilities/ Super Specialities hospitals, in western Uttar Pradesh, near New Delhi may kindly be considered favourably. I shall be highly obliged to Hon'ble High Court.
