**Diagnosis:** Rt UL CRPS + Rt SHOULDER PAIN

**Procedure –** Rt SUPRASCAPULAR NERVE MIPSI + Rt STELLATE GANGLION BLOCK

Consent taken.

Patient shifted to OT Monitors attached.

Complete asepsis ensured by prepping (Savlon --> isopropyl alcohol, betadine for 5 mins) and draping.

Patient in right lateral position, Rt SUPRASCAPULAR NERVE MIPSI + Rt STELLATE GANGLION BLOCK done Under USG guidance, after local infiltration of site with 1% lignocaine, done . drug given after negative aspiration of blood. Procedure uneventful. In the OT, patient was hemodynamically stable and no neurological deficits was there. Patient discharged after observation for 2 hour.

Advice:

1. Tab Cefixime 200 mg BD X 5 days
2. Tab Lyrica 75mg BD X 1 month
3. Tab Tryptomer 25 mg HS X 1 month
4. Tab Zolfresh 10 mg HS
5. Tab Tramadin plus / Ultracet / Narcodol TDS x 5 days then SOS
6. Cold fomentation on the inj site for 2 days
7. Continue exercises after 2 days
8. Review after 2 weeks in OPD

*Patient is advised monthly visits to monitor progress of pain & Allodynia and perform regular nerve blocks if required.*
