- 1. That my father Mr. Mohammad Mustafa Khan, Aged 76 years has suffered a brain stroke (ISCHAEMIC CVA (Right Basal Ganglia Infarct) on 06.12.2023 causing him left sided hemiplegia. He was admitted in the Nova Hospital, Lucknow on the same day. Thereafter, he had to be shifted to ICON Hospital, Lucknow on 07.12.2023. He remained admitted in the ICON hospital till 12.12.2023. Due to the brain stroke the left side of my father is not working, he is bed ridden.
- 2. That, my father has already been suffering from hypertension, diabetes, osteoarthritis, spondylitis and prostrate diseases.
- 3. That, the aforementioned co-morbidities have made his position quite sensitive. Looking at the present situation of my father, doctors have advised that he will take a considerable time to be able to recover from this medical condition and have emphasized on the fact that he requires specialized treatment, continuous monitoring and continuous nursing.
