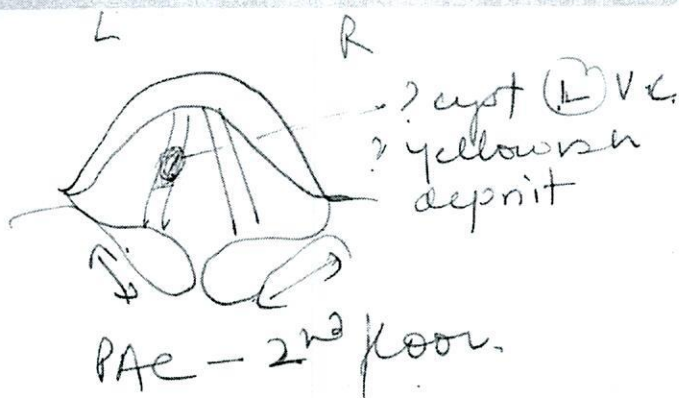

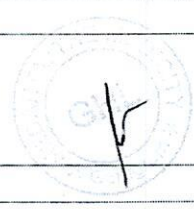

#### Course in Hospital

<b>Procedure or Surgery</b>	: Patient was admitted in Daycare and was planned for LASER Microlaryngeal Surgery under GA on 22/2/24. Rest of the post operative period was uneventful. Patient is discharged on 23/2/24 LASER Microlaryngeal Surgery under GA on 22/2/24 by Dr ACH/Dr KKH/ Dr SS Findings- cystic swelling involving anterior 1/3rd of left true vocal cord Procedure- Under all aseptic precautions, patient CPD done. Direct laryngoscope introduced. Lesion adequately exposed and laryngoscope fixed with suspension. Using CO2 laser at 10 watts, lesion excised and specimen sent for HPE. Hemostasis achieved. Laryngoscope withdrawn. Patient extubated and shifted to recovery. Immediate post operative uneventful.
