Subject : Request cum Representation regarding Premature Transfer.

Respected Sir,

With utmost humbleness, I have to submit that, I have been transferred to Mirzapur from Mahoba Judgeship in the Annual chain transfer of 2024 and currently I am serving as Chief Judicial Magistrate, Mirzapur from 15.04.2024.

Sir, most respectfully, I want to bring it to your kind notice that since year 2017 I have been suffering from Ankylosing Spondylitis also known as axial spondyloarthritis. It is an inflammatory disease and from last 6 years has been consistently causing fusion in the spine and its bones. The fusion has made my spine very less flexible and has resultantly affected the ribs. It has adversely affected my body posture and I often find hard to stand straight or sit for long hours. My posture is consistently bending and is now a hunched posture. My medical report also shows that I have been diagnosed and tested positive for HLA-B27. Furthermore, it is most humbly submitted that my wife Mrs. Sapna Tripathi is also often medically ill and is suffering from chronic renal (kidney) disease. She is undergoing her treatment at Sir Ganga Ram Hospital, New Delhi under the medical supervision of Dr. (Prof) A.K. Bhalla.

Sir, It is most humbly submitted that previously I was posted at Mahoba, and I had represented for transfer on the same medical ground as there was no adequate medical facility available and distance from Delhi to Mahoba was more than 500 Kms. My application was considered in view of my deteriorating medical condition but instead I was transferred to Mirzapur in the annual chain. Sir, this has made my situation more difficult as Mirzapur also does not have any medical facility or physiotherapy centre and my distance from Delhi has furthermore increased to 785 Kms, where at my present I and my wife are undergoing our treatment.

Sir, it is to further state that due to our deteriorating medical condition it is very difficult for me to perform my judicial functions effectively. As in District Mirzapur there are no adequate medical facilities and medical professionals (physiotherapy specialist) and thus, I, find it extremely difficult to manage my proper medical treatment. The treatment of my wife is also getting affected due to the far distance from delhi. Currently I am undergoing medical treatment at Indian Spinal Injuries Centre, New Delhi and consulting Dr. P.D.Rath for my effective treatment whereas my wife is undergoing her medical treatment at Sir Ganga Ram Hospital, New Delhi. The distance from Mirzapur to Delhi is about 785 km and thus it is becoming very difficult for me and my wife to manage our medical treatment as due to my hunched back I cannot travel far.

Therefore Sir, it is my most humble request that if you may kindly consider my deteriorating medical condition and reconsider my place of posting to stations like GautamBudh Nagar, Baghpat, Ghaziabad, Meerut or Muzaffarnagar as at such places there would be adequate medical facilities, physiotherapy centre available for effective treatment. Scanned copy of medical papers and reports of mine and my wife are attached with the application for your kind perusal. I will be highly obliged if you could consider my situation.

Kindly place my request before the Hon'ble Court for reconsideration by their Lordships. For this act of kindness, I shall ever be obliged to you.
