

## **Affidavit**

I, the deponent Tarif Mustafa Khan S/o Mr. Mohammad Mustafa Khan, aged 34 years, R/o- House No. J-10, Judges Colony, District- Azamgarh, presently posted as Nyayadhikari, Gram Nyayalaya at tehsil- Mehnagar, District- Azamgarh hereby solemnly affirm and state as under-

1- That in continuation of my transfer application No. 3082, it is submitted that in addition to the medical issues mentioned in my transfer application No. 3082, my father suffered excruciating pain in the intervening night of 28/29<sup>th</sup> June, 24 and was subsequently diagnosed with 'Gastric outlet obstruction with cecal volvulus with intestinal obstruction'. The problem couldn't be managed through medicine. The surgery was major and critical owing to his health condition. I am reproducing the relevant content of my my transfer application No. 3082 stating his health condition-

"...my father has suffered a brain stroke (ISCHAEMIC CVA (Right Basal Ganglia Infarct) on 06.12.2023 causing him left sided hemiplegia. He was admitted in the Nova Hospital, Lucknow on the same day. Thereafter, he had to be shifted to ICON Hospital, Lucknow on 07.12.2023. He remained admitted in the ICON hospital till 12.12.2023. Due to the brain stroke the left side of my father is not working, he is completely bed ridden.

In addition to that it is submitted that my father has already been suffering from hypertension, diabetes, osteoarthritis, spondylitis and prostrate diseases."

But as there was no other treatment option he had to be operated on 08/07/2024. Laparoscopic Right Hemicolectomy with Cholecystectomy was performed on him on 08/07/2024 in Max Super Speciality Hospital, Lucknow. After the surgery he was discharged from the hospital on 15/07/2024. Post discharge his health condition kept on deteriorating.

- He suffered from hypovolmic shock on 18/07/2024
- He had to be admitted again to the hospital on 19/07/2024 for F/U/C/ of Laproscopic Right

Hemicolectomy with cholecystectomy with hypokalemia with intestinal paresis. He was discharged on 23/07/2024.

- He had to be admitted again to the Hospital on 02/08/2024 as his health was not improving. His stomach was distended. He was not able to eat anything, His body was severely dehydrated. He was discharged on Mathil 13/08/2024 with following future plan 1. Endocrine and No was consultation for persistent hypokalemia. 2. Cardiology Luckrow of the Proposition of CAD. 3. Neurology consultation for carotid artery stenosis.

- 2- That today, when I am writing this representation his health condition is unfortunately still not getting better. He is totally bed ridden. His mental condition is also not good. His treatment requires the involvement of Gastrology, Neurology, Cadiology, Endocrinology, Pshychiatry, and Nephrology faculties.
- 3- That, my father is under treatment in District-Lucknow. The desired treatment can be provided in District-Lucknow as his health condition requires multispecialty hospitals of tertiary level care. Looking at the present situation of my father, doctors have suggested that he will take a considerable time to be able to recover from this medical condition and have emphasized on the fact that he requires specialized treatment, continuous monitoring and continuous nursing.
- 4- I am currently posted in District- Azamgarh and it is not possible for me to provide the desired treatment to my father in District- Azamgarh. I am the only son of my parents. I have one elder sister. My parents are totally dependent upon me. I am the only person to look after my ailing father.
- 5- That, in compliance of the Hon'ble Court's order I have annexed the medical assessment report of my father issued by the Chief Medical Officer, Lucknow. The Chief Medical Officer, Lucknow has mentioned in his medical assessment report Dated: 17.08.2024 that disease of my father is mentioned at paragraph No. III of Annexure I of the Hon'ble Court's Letter No. 94/Admin. (Services)/2024; Dated: February 19, 2024 and the





treatment of my father is possible only in any big city with multispecialty hospital of tertiary level care. Furthermore, he has observed that my father is already undergoing treatment in Lucknow.

That, in light of the above facts and circumstances it is humbly requested to your goodself to R.K. Mathur compassionately consider the aforementioned dircumstances of the undersigned and if in light thereof Regd No 11-12912100 your goodself deems it fit then it is most humbly prayed Corroftle undersigned to it may kindly be pleased to transfer the undersigned to the District- Lucknow, so that he shall be able to discharge his professional as well as personal duties with utmost commitments. The undersigned shall always be grateful to your goodself.
