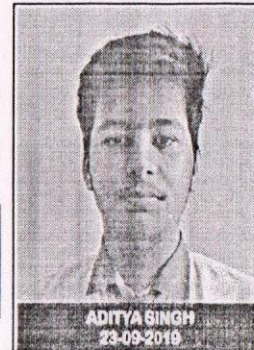

It is, therefore, humbly requested from the Hon'ble High Court that my posting at Bijnor may kindly be stayed for one year.




