

## U.S.G FOR FOETAL WELL BEING—LEVEL II

A single live intrauterine foetus is seen with Cephalic presentation.

Foetal cardiac activity is ++, regular and measures 140 **BPM**.

Foetal movements are ++

Placenta is **posteriorly** situated away from os. Placental maturity is grade I

Retroplacental region is clear.

Liquor content appears adequate.

Foetal head shows normal dimensions with normal ventricular choroid ratio

Cerebellum measures in normal length. No evidence of vermian hypoplasia

4mm . Lateral ventricles measures 6mm in diameter . Cisterms megna measures Choroid plexuses to ventricle ratio within normal limits

Face shows normal symmetry with normal inter-orbital distance. No obvious craniofacial asymmetry noted

Foetal bladder and stomach bubble are well visualized

Foetal limbs appears symmetrical and normal

Foetal cardiac axis appears normal . 4 chamber view shows no gross abnormality. Outflow track appears within normal limits Small echogenic foci seen in ventricle ? insignificant (for detail study needs echocardiography)
